

An estranged visitor to our country would of been puzzled to see such an attitude in people at a time of the year when life is anew. After all, the signs of Spring were all there: sunshine, blossoming flowers, lustrous rainbows, glistening grass at the ballpark, the smell of hot dogs at the ballpark, the crack of the...Oh no! There was no crack of the bat at the ballpark; no snapping sound of the ball hitting a catchers mitt at 90 mph; no dust kicking up from a hustling slide at third...

THERE WAS NO BASEBALL!

Major League players had gone on strike. Fans everywhere had lost hope with the game that had fused itself with the identity of the American people: no longer could the people look to baseball for their mythical heros.

But on one Spring day at Wrigley Field, when the sun was out, there loomed amongst the white puffy clouds an ominous gray cloud, which hovered incessantly over the ballpark. And as the gray cloud casted its shadow over Wrigley, it released a mysterious clairvoyant message that reached the minds of all Major League ballplayers throughout the country, alluring them to come to the ballpark.. A BASEBALL LEAGUE NAMED THE ASBL!

A league that will play the game as it is meant to be played. No lock outs, no fat cats, no high ticket prices, no lushes batting .220 and getting paid 4 million dollars. No, this league will have players who hustle to first on routine ground outs and aren't afraid

to slide and dive and get a little dirty or confront a wall or a husky catcher at full speed. These players will play baseball. And with their eagerness to play, shining bright for all to see, Americans will restore their faith in the one and only national pastime...BASEBALL!

The ASBIReal Story

Just like baseball has a real origins story hidden behind the Abner Doubleday myth, so too does the ASBL. In late spring of 1995, when the popularity of major league baseball was at an all-time low due to the strike that left a 1994 season unfinished, James Riquelme set out to start a simulated baseball league using the Strat-o-matic computer game. At the time Strat-o-matic was a fairly new toy for him. He had tried other simulated baseball games before, but none of them fulfilled his desires of playing a realistic computer baseball game. On a late night in a game's message board on AOL James made his discovery of the Strat-o-matic baseball game. He describes his discovery as a "finding of lost treasure." He goes on to say, "In those days—well even now—there were really no sophisticated simulated baseball games for the Mac. The games that were out there were either simple shareware versions or commercial games that no longer were making upgrades for the Mac."

So after playing solitaire with his newfound toy James set out to play

in a league. But there was a problem: there were no leagues out there for Macintosh Strat-o-matic users. He soon realized that if he wanted to be in a league using Strat he would have to start one up himself. And that's exactly what he did. He sent emails out and posted advertisements on message boards looking for Mac Strat-o-matic users. And within a few weeks he had 20 members in his league. However not all of them were Mac users; there were two or three PC users, but the league still stated it was a Strat league for Mac users (currently the league is about 50/50 when it comes to Mac/Window users and is no longer "just a Mac user" league.)

It was a bumpy road at first. Rules, procedures and a start-up draft had to be put together before the season could start. For James it was very tough. This is what he says about that time in his life, "Man, when I started up the league I was very reluctant at being in charge. At the time things weren't going too well in my life, and hell, it was about to get worse with the car accident. But I so badly wanted to be in a league that I kept with it."

The league made it through the draft and a few months of the season. It was during these first few weeks of the season that I joined the league as new owner of the Vermont Hurricanes. I discovered the league by reading about it in the AOL Mac game sports message boards. Back then much of the league information, stats, and trade talks took place via the message board. When I found out that the league was tailored for Mac users I wrote several emails to James begging him to let me be in the league. When the first opening came around he sent me an invite to which I immediately accepted.

But not long after I joined tragedy struck. James was in a near-death car accident that left him in a coma for over a month. For much of the time that James was in a coma the league did not know about it. Most everyone, including myself, thought the league was dead. Many members left the league, but a few of us hung around hoping for James to return. A brave attempt by Jon Bricker to get the league going again was made. But he didn't really have the time to keep the league running consistently. Finally after learning what happened to James, sometime in January of 96, I took it upon myself to get the league up and running again. I replaced the owners who left with new ones and played out the 1995 season in auto mode on the computer. We managed to get the playoffs done in time to get ready for the 1996 draft. And ever since then I've been the commissioner of the ASBL.

I'm glad to say that James has returned to the league since his car accident as owner of the Portland Lumberjacks, the same team he had when he left. He still is in constant therapy for his back, but he still manages to be a major contributor to the ASBL. Last season he ran all EL games and he's in charge of creating the page layout for the guidebooks and newsletters.

So there it is, the real story of how the ASBL got started. In some ways this story may be stranger than the mythical one. How the league survived its tumultuous start to become what it is today is truly incredible—a feat that never could have happened without the significant contributions of many. I truly feel that as long as this league adapts to new technologies and remains focused on having fun, it will be around for many years to come.

LEAGUE OPERATIONS

•The regular season is comprised of all 12 teams from each league playing 162 games. The Western League(WL) teams will never play the Eastern League(EL) teams during the regular season

•An ASBL actual week will consist of each team playing six games. The six games will include two 3-game series or a 4-game and 2 game series.

•One simulated day off will be granted at the end of every ASBL week(every six games). Owners will always receive player stats after the days off have been granted.

•For the 1999 ASBL season all players stats are multiplied by 1.3, which will reflect the maximum appearances a player can make in a regular season.(On player utilization rules, please see rule 1a in the rules chapter)

•All games will be run with the following options: **Under rules**--main rules at maximum level; BP, weather & clutch effects on; super advanced steal system, super advanced strategy charts, use miscellaneous rules, use closer rules, use injuries, use SADV fatigue rules, allow GBA on pitcher cards, improve statistical accuracy, bunt for base hit, improve out distribution, improve baserunning realism, home field advantage, starting pitcher clutch, more baserunning decisions, doubles/triples options. **Under lineups and useage**--lineups in manual mode; ignore overuseage; SuperHal.

•All games will be run by impartial gameunners and manged by the computer.

•Playoff games will be played online live

PITCHING SHEETS(PS)

On each Monday by11:59 PM EST an optional pitching sheet (PS) from each owner will be due. The PS will be done by e-mail and contain the starting pitchers for each game played in the week. If a PS isn't turned in for the week the default managers rotation will be referred to. To the right is an example of what a PS might look like.

Include in the subject of the PS email your team name and the current week number of the season (i.e., Knoxville's Wk1 PS). Once it is completed send it to the people in charge of your league's PS and the commissioner.

COMPUTER MANAGERS(CM)

The following sections will cover the computer manager (CM) system used in the ASBL. The ASBL provides owners with many options on how to set up their CM from week to week. Hopefully after a while you'll find the option that is best for you and your team.

DEFAULT CM

A default setting for a team's CM will be used whenever a team doesn't send in their weekly CM. The default CM setting should include pre-set lineups versus left handers and right handers (make the #1 preset vs LH and the #2 preset vs RH), pitching rotation, twenty-five active player roster, substitutes, manager tendencies, SuperHal settings, and player settings. If you want you can include in your preset lineups a lineup vs reverse right handers and left handers(see sidenote 1 to see what a reverse RH and LH are and see graphic A to see an example of a preset lineup that contains reverse RH and LH lineups) The following is an example on how to send a default CM.

•After setting your default CM to your liking, under the team menu select export computer manager as shown in graphic B to the right.

•A window will now appear prompting you to enter a password, as shown in Graphic C to the right. Leave it at 0 to enter no password and click ok.

•Now you will be asked to save your file. You should save it as your city's team abbreviation and the abbreviation def for default with the suffix of mgr at the end, as shown in graphic D to the right.

•Then attach the file to email. The subject of your email should include your team's city name or abbreviation followed by the words default CM, as in the following Knoxville example: KNO Default CM.

•Then send it to the commissioner, which is currently me at LawsonBoy@aol.com, and you're all done.

Throughout the season you can change your default CM as many times as you like. When new players are acquired the commissioner will make changes to your default CM. These changes will remain until a new default CM is turned in.

WEEKLY CM

Weekly CMs are turned in each Wednesday by11:59 PM EST. for owners who want to tailor their CMs to matchup against specific opponents. Each week owners have three choices they can make regarding CMs: The first is turn in two CMs, one for each of the two series played; the second is turn in one CM for both series played; and the third is don't turn in any weekly CM and let the default CM manage. All three choices are perfectally acceptable.

Option #1: Turing in two CMs, one for each series. The main benefit of turning in two CMs is the following: lineups can be different for all 6 games. In so doing you would name each preset lineup by what number game it is in the week, just as graphic A1 shows to the right. The second CM should then have preset lineups for games 4-6. Another benefit is the ability to have more control of who to call up. Let's say there is a player you want called up from the minors for the first series, but you want him back in the minors for the second series. Turning in two CMs would be the only way you could do this. And lastly, you can change manager tendacies, substitutes and player settings for each series with two CMs.

The way you would turn in two weekly CMs is the following. After setting your CM for your first series, export your CM, just as you would do your default CM, but when asked what to save it as, save it as your team's city abbreviations, Ser1 for series 1, and the mgr suffix. So for example Knoxville would save their series 1 CM as KNOSer1.mgr. Next go and make changes to your CM for series two. Do the same thing you would do for series one, but call it Ser2 instead. So for example Knoxville would name their series 2 CM, KNOSer2.mgr. Then place both files in a folder with your team's city abbreviation and the week number (i.e. Knoxville in week one Knoxville would name their folder, KNOWk1). Then attach the folder to email and name your email by your team's city abbreviations and the words weekly CM (i.e., Knoxville would name their email KNO Weekly CM). Then send it to the commissioner. *For Window users, zipping your attached files is fine; I have no problems decompressing zipped files.*

Option #2: Turning in one CM for both series This CM would cover both series. You may not have as many options as you do when sending in two CMs, but you can still have up to five preset lineups. So let's say that one week a team wants to keep manager settings and minor league players the same for both series, but have five different lineups they want to use. Having five different lineups means that two games will share the same preset lineup. To save yourself from going through the extra work of sending in two CMs, just use one preset lineup to cover both games. So lets say it's games 2 and 6 that will have the same lineup. Your preset lineup for the week would look like graphic B1 to the right.

Or let's say an owner wanted to use a vs lefty, vs righty lineup for most of his games except for one. He could have a preset lineup vs lefty and vs righty and one preset for the game the lineup is different. As shown in graphic C1 to the right. Or lastly, it's perfectally allright for an owner to send in one CM with just a vs. lefty, vs righty or reverse RH/LH lineups as well.

The way you would turn in one weekly CM is the following. After you have changed your CM for the week, export the CM and save it as your team's city abbreviation, the week it is, and the mgr suffix at the end (i.e., Knoxville in week one would save it as KNOWk1.mgr). Then attach it to email and name your email after your team's city abbreviation and the words weekly CM, as mentioned in option 1. Then send it to the commissioner

Option #3: Don't send in a weekly CM and let your default CM manage. This is a great option to use when you plan to be away for any long period of time or your just to busy to work on a weekly CM. How to setup and send a default CM is covered on the previous page.

1: The American Strat-O-Matic Baseball League will always use the latest version of Strato-matic. It is mandatory that all league members have the most current version in order to be in the league. CDROM Version 5 is the version you must have to play in the year 2000

2: The DH will only exist in the Eastern League.

PLAYER UTILIZATION & ELIGIBILITY

1a: Maximum Utilization— There will be a 130% utilization restriction on each player, which will be adjusted into the players stats when you receive your official Strat-o-matic rosters. Once a player has reached his maximum appearance during a regular season he must be deactivated for the remainder of the regular season. Appearances for batters are based on plate appearances (AB+BB); appearances for pitchers are based on innings pitched.

2a:Minimum Rule—For a player to be eligible to play in the ASBL he must meet the following requirements:

•Position Players with at least 40 actual Major League plate appearances (which equal 52 plate appearances after 130% usage adjustment).

•Starting Pitchers with at least 35 actual Major League innings pitched (which equal 45 innings pitched after 130% usage adjustment).

•Relief Pitchers with at least 20 actual Major League innings pitched (which equal 26 innings pitched after 130% usage adjustment)

Those pitchers designated Starter/Reliever must have more than 35 actual Major League innings pitched (45 innings pitched after 130% usage adjustments) to qualify as a starter, but if they have over 20 actual Major League innings pitched (26 innings pitched after 130% usage adjustments) they can relieve. A team can still draft players who don't meet these requirements they just will not be allowed to play in the season.

3a: In the regular season players cannot start at positions they are not defensively rated for, unless there is no one else available to play the position. Outfielders are the exception to the rule. They are allowed to swap positions amongst the outfield only. The Strat-o-matic adjustment ratings for outfielders will be used to determine ratings for out-of-position outfielders* (See sidenote 1 for how SOM adjusts defensive ratings for out of position outfielders). Note, since the league is computer managed during the regular season, it is beyond the control of the owner if during a game the computer decides to substitute in at a position a non-rated player, therefore the owner will not be held accountable.

INJURIES

1b: The league will use Strat-o-matic's Basic Injury rule to determine when a player is injured however the result of the injury will be converted by using the ASBL Injury Conversion Chart. All injury results that occur during a week will be noted by the game-runner but then erased immediately after the games the injuries occurred, allowing the injured players to continue to play until the end of the week. At the end of the week all injury results will be reported to the commissioner and he will then refer to the ASBL Injury Conversion Chart to determine the length of a player's injury; all injuries will then begin at the start of the new week. There will be a maximum amount of days a player can be injured during the regular season. Once a player has reached his maximum amount

of injuries for a regular season, the commissioner will edit the player's card by erasing all injury chances, hence making it impossible the player will be injured again during the regular season *(see sidenote 2 on why a pitcher's card can't be edited for injuries and how SOM determintes injury to pitchers). A player's converted injury result and maximum amount of injured days in the regular season is determined by a player's injury status. A player's injury status can be the following: Ironman, Rarely, Sometimes, Prone, Brittle, Very Brittle and Timebomb. You can view a batter's injury status by double clicking on a player in the manager's window of the Strat-o-matic game. Since Strat-o-matic does not apply injury statuses to pitchers, a pitcher's injury status will be determined by reviewing all pitchers' injuries the previous Major League season and then applying an injury status accordingly. A list of each pitcher's injury status will be released prior to the start of the preseason. Below is the ASBL injury conversion chart:

because injury results do not come from a pitcher's card. Strat-o-matic's basic injury rule determines a pitcher's injury in a non-dh league when an injury result comes off the pitcher's batting card. Strat-o-matic applies different generic batting cards to pitchers, depending on the pitcher's hit ratings. All of these generic cards have the same chances of resulting in an injury. In a DH league the Strat-o-matic Basic Injury Rule determines a pitcher's injury when the DH of the opposing team is at-bat and the dice result in a roll of 6-12

\rightarrow SIDENOTE 3 **An occurrence** under the maximum amount of injury column refers to one period that a player is injured. The maximum amount of injury occurrences can result in a player being injured less than the maximum amount of days but never more. Here's an example of a couple of maximum amount injury possibilities to a Sometimes injury status player: A Sometimes injury status player can be injured 21 days or 3 occurrences. So

ROSTERS

1c: Each team will be limited to an active roster of twenty-five players until the simulated month of September. The active roster can consist of any combination of fielders and up to 15 pitchers. In the simulated month of September all position players and up to 15 pitchers may be activated for the duration of the regular season. Through the simulated months of April to August players can be activated and deactivated as desired, but during these months no team will be allowed to have more than twenty-five players on their active roster. There is a maximum of 40 players per teams (ineligible players included). No team may drop below 30 players at any time.

FREE AGENTS

1d: Owners may acquire free agents during the regular season as long as they don't go over the 40-player maximum (ineligible players included). Free agents are players who weren't picked during the draft. Free agents can't be protected for next season.

2d: Once you drop a player to free agency he acquires free agent status for the remainder of the season and no team can protect him for next season.

3d: Free agent pick-ups will be done on a first comes first serve basis. A 24-hour waiting period will be required before these players can be obtained. In the event there is more than one team who claim the same player within a 24 hour period, a coin toss will determine who will receive the player.

TRADES

1e: Trades can occur at any time during the regular season, except in the simulated months of September and October. No trading can be done during the post season. Trades can occur during the off-season as well.

2e: Any trade must be e-mailed by both members to the ASBL commissioner before it is approved. For trades to go into effect for a given week during the regular season, they must be turned in by Monday night.

3e: During the draft period teams need to announce proposed trades to the commissioner. The commissioner will then review trades for approval. If a trade is approved during the draft period it is the responsibility of the owners to keep track of the trade for the duration of the draft. The commissioner or draft manager will announce a few days prior to the draft a "No Trade Announcement Period." Hence, the commissioner or draft manager will not edit the draft order to accommodate any trades made during the draft period, so it will be up to the owners to be aware of what picks they traded for.

4e: If a free agent player is involved in a trade, it is the responsibility of the owner of the free agent to notify the other owner involved that a free agent is being traded.

5e: The head commissioner reserves the right to veto any trade he determines detrimental to the good of the league.

for maximum amount of injured days we know that if all his injuries equal 21 days he can be injured no more. Now if he's injured 3 occurrences and two of them are for 4 days and one is 7, that would be a total of 15 days, however since it is 3 occurrences he has reached his maximum amount of injuries in a regular season and can be injured no more. Please note that if a player receives an injury that will exceed his amount of maximum injury days, the injury will be reduced so not to exceed his maximum of injured days (i.e., a sometimes injury status player has been hurt for 15 days. He receives an injury result of 15 days, but it is reduced to 6 days so not to exceed his 21-day injury maximum).

→*SIDENOTE* 4

A 3-day injury can be extended to 4 days if the first series of the week is a 4-game series. 4-game series will be played in the last 10 weeks of the season.

ASBL RULES continued BALLPARKS

1f: The ASBL uses Major League ballparks that have Strat-o-matic ratings given to ballparks from the previous major-legue season played.

2f: There will be no duplicate ballpark ratings in the ASBL (i.e., no two Yankee Stadium ratings, etc).

3f: Ballpark Change Restriction Rule: An owner can only change their ballpark in the following circumstances: One, the owner is new and wasn't involved in deciding their team's current ballpark; two, the ballpark no longer exist (i.e., the ballpark has been renovated or no longer is played in); three, an owner was involved in the duplicate ballpark move of 98 and is allowed one ballpark change within three seasons, in which they'll have priority of choice over ballpark moves done by new owners; four, an owner has played three seasons in the current ballpark and can now request a change. If one of these circumstances apply, the owner can only pick from a ballpark that isn't currently being used in the ASBL.

4f: An owner can name their ballpark as they so desire as long as the commissioner or other league members do not find it offensive.

POST SEASON

1g: Four teams from each league will make the playoffs. Those teams are the two teams that win their division and two wild-card teams. The wild-card spots will be given to the teams with the next best record to the division winners in the league. If teams are involved in a tie to make the playoffs, a tiebreak will be decided by a one game playoff— home team to be decided by a coin toss.

2g: The division winner with the best record will play the last wildcard team, and the division winner with the second best record will play the first wildcard team in the first round playoffs.

3g: There will be a best of five first-round series, with a 2-3 home game format, with the division winner having home advantage. The winners of the first round series will play in a best of seven league championship series, with a 2-3-2 home game format, with the division winner having home advantage, unless both teams are division winners or wildcard teams, in which case the team with the better record will have home field advantage. The winners of the league championship series will play in a best of seven ASBL Championship Series, with a 2-3-2 home game format, with the team with the better record having home field advantage.

4g: The DH rule will only be used in the EL's postseason games and the EL team's home games for the ASBL Championship.

5g: There will be a 10% utilization rule of a player's actual Major League plate appearances and innings pitched during a playoff series. Players who are exception to the rule

are batters with 503 actual Major League plate appearances and above, pitchers who have an asterisk on their endurance rating, and the choice of one closer with 50 or more innings pitched. When a player goes over the 10% utilization, they will be removed from the active roster for the remainder of the series.

6g: In the playoffs starters need a minimum of 3 days rest between starts regardless of the tired status determined by Strat-o-matic. The one exception is the following: if a starting pitcher is pulled out in the early innings of a game (early innings being 1st through 4th) because he is being blown out and the Strat-o-matic Advance Point Of Weakness rule determines him to be tired, then and only then the manager can start him again on the day that Strat-o-matic's Super Advanced Starting Pitchers Rest Chart determines him not to be tired. Below is the Super Advanced Starting Pitchers Rest Chart for the first 4 innings:

Please note that the 1 day rest does not include the day the pitcher made his previous start.

7g: In the playoffs a starter who has no relief endurance ratings can only pitch a maximum of 1 inning in relief per game (an inning consist of 3 outs). The only exception would be is if the pitcher in question is the only pitcher remaining.

8g: Minimum Playoff Usage Rule. A position player under 100 actual Major League plate appearances cannot be in the starting lineup during postseason play. He can only come off the bench as a pinch hitter or defensive replacement. He may only replace a starting player in the lineup after 6 innings of play, or if there is an injury during the game he can replace the injured player at any time, but he still can't start the following games if the injured player is still out, unless he is the only one available as a replacement.

9g: In the playoffs players cannot start or be substituted in at positions they are not defensively rated for, unless there is no one else available to play the position. Outfielders are the exception to the rule. They are allowed to swap positions amongst the outfield only. The Strat-o-matic adjustment ratings for outfielders will be used to determine ratings for out-of-position outfielders (see sidenote 1 on pg 12 for OF adjustemt chart).

10g: Injuries will carry over from regular season play to post season play.

11g: Injuries can occur during post season play. Injuries will be determined by the Strato-matic Basic Injury Rule, but the maximum days a player can be injured is 5 days; any injury results larger than that will be reduced to 5 days.

12g: Teams can only have a twenty-five player active roster during post season play. The twenty-five-man roster must be announced before a series begins and cannot be changed

during the series; however, it can be changed for the following series, but it still must be 25 players.

13g: All playoff games will be played live online as manager vs. manager games. A playoff series must be played within a 2-week period. If after two weeks the series is not played it will be played as a computer vs. computer game run by an impartial game-runner chosen by the commissioner. If the commissioner or the person in charge of running the playoffs feels that one party is mainly responsible for the inability to complete the series live, the commissioner or playoff manager will make every effort to have the manager who has been available manage his team live, even if it's against a computer managed team.

14g: If a manager of a playoff team cannot manage his games live he can select a replacement manager to manage for him.

15g: At the time of the game any disputes or controversy shall be resolved by the game runner. If one of the owners is not happy with the resolution he can petition the game by sending in a detailed complaint to the commissioner. The commissioner will review the petition and make a judgement. If the petitioner or the petitioner's opposing team manager is not satisfied with the commissioner's judgement he can appeal the judgement and chose to bring his argument to a vote amongst a 3-person panel assigned impartially by the commissioner or a vote amongst the entire league. Prior to making the choice of which entity shall vote the appealer will be informed of the 3 people in the panel. The appeal entity will receive an argument from the appealer and an email from the commissioner stating his reasons for his judgement. The appealer, the commissioner, and the appealer's opposing team manager cannot communicate with the appeal entity while the appeal is in process, unless the appeal entity wishes to ask a question of one of the parties. DRAFT & PLAYER PROTECTION

1h: There will be a twenty-two round draft at the beginning of the season. The draft will be done in two parts, on-line and off-line. In the first three rounds the team with the worst record the previous season will draft first, followed by the team with the second worst record, etc. The winner of the ASBL Championship will pick last. After the first three rounds a serpentine draft order will be in effect for the remainder of the draft.

2h: Owners will be able to protect 13 players for the following season. Players that aren't protected will be released to free agency and included in the draft. Which thirteen players a team will keep will be announced approximately one month before the draft.

3h: All carded players are available for the draft. This includes players who do not have enough appearances to be eligible to play in a game(see rule 2a, Minimum rule, on pg 12 for player eligibility information). Thus any player who made a major league appearance the prior season is eligible in the draft, even if he does not have the minimum amount of appearances to be eligible to play in a game.

continued

4h: If a player was not carded for the previous season he is not available in the draft. This includes players who have received cards in the past, but didn't receive cards for the previous season for various reasons—i.e., injured for the year, went to Japan, played in the minors all year, etc.

5h: Non-carded Player Retainment rule. A non-carded player who is on your team's roster from the prior season can be retained as one of your 13 players protected. If a non-carded player is not protected prior to the draft he becomes subject to rule 4h, hence making him unavailable for the draft.

6h: Teams who are short of 35 players at the end of the draft will be involved in compensation rounds until they reach 35 players; the order will be determined by last season's record (worst to best).

7h: Teams that have picked up extra draft picks will have a limit of 40 players on their team. Teams that go over the 40-player roster limit during the draft, but still have draft picks remaining, may still participate in the draft, but they will be required to release to free agency any extra players they have immediately following the conclusion of the draft.

8h: If a GM cannot be available on an on-line draft day, he must supply another owner, the draft manager or commissioner with detailed draft instructions and understand that this system is imperfect and that the owner, draft manager or commissioner is in no way responsible for draft mishaps.

FRANCHISE

1i: A franchise location has to be named after a real city or state in the North American continent

2i: Franchise locations can be moved at an owner's request, but only if the new location will align geographically with the division they are currently in.

3i: If a franchise location move requires a division change, a 70% league approval will be needed.

4i: An owner can name their team as they so desire as long as the commissioner or other league members don't consider it offensive.

MISCELLANEOUS

1j: Common Courtesy Rule: If an owner does not respond to their email in a three week period (this includes email from other owners who may be proposing trades) and/or does not contact the league that they will be gone for a substantial period of time, the commissioner will try to contact him by phone or e-mail, and if there is no response the commissioner has the right to replace him.

2j: At no time shall a manager be running more than one team.

3j: All owners should have the intent of trying to win every game. Any owner who is blatantly trying to lose games will be removed from the league.

4j: The ASBL commissioner shall be empowered to act unilaterally in the best interest of the league

5j: New rules, amendments to the rules and other voting league matters shall require a 70% vote approval, with at least half the league members voting. So for example, if a vote result is 10-3 with 7 abstentions, the vote passes. If however the vote is 9-0 with 11 abstentions the vote will not pass

6j: Any league member can make a proposal. If a proposal is voted down, it can be proposed again the next season only if it got at least 40% of the vote the previous season. Otherwise there'll be a waiting period of three seasons before it can come up again.

7j: During the course of the regular season there is a chance game-runners will make mistakes. If you notice a mistake by a game-runner please notify either the commissioner or the game-runner and every effort will be made to address the problem. Game-runner mistakes will never result in the re-running of games.

8j: During the regular season if an owner has a complaint concerning a game or games he can send in his complaint to the commissioner. The commissioner will review the complaint and make a judgement. If the petitioner or the petitioner's opposing team manager is not satisfied with the commissioner's judgement he can appeal the judgement and chose to bring his argument to a vote amongst a 3-person panel assigned impartially by the commissioner, or bring his argument to vote amongst the entire league. Prior to making the choice of which entity shall vote the appealer will be informed of the 3 people in the panel. The appeal entity will receive an argument from the appealer and an email from the commissioner stating his reasons for his judgement. The appealer, the commissioner, and the appealer's opposing team manager cannot communicate with the appeal entity while the appeal is in process, unless the appeal entity wishes to ask a question of one of the parties. Also prior to the appeal process, other than sending the appealer's argument and the commissioner's judgement statements, the appealer, commissioner, and the appealer's opposing team manager cannot communicate with the appeal entity. Please understand a decision will rarely result in replaying a game or series during the course of the regular season because it will severely interrupt the process of how games are run. The commissioner or appeal entity will find other ways to compensate a re-run game appeal if they feel it will severely interrupt the running of the league.
