**WARRANT INFORMATION:**

During the months of June and July of 2014, the above listed suspect did knowingly and intentionally perform several acts of Bestiality by

- (1) Allowing her family dog lick her vagina and recording it on video
- (2) Performing oral sex on the penis of her family pet and recording it on video
- (3) Placing her family dog's penis inside her vagina and recording it on video

The videos clips and other still photos of the same acts were recorded by her husband and herself and then posted onto a website called Beastforum.com

The photos and videos were viewed and flagged by Detective Jeremy Hoffman from The Fairfax Virginia County Police Department. After an extensive investigation into the posts, it was determined that the posts were from Anderson, Indiana. The information was forwarded to The Madison County Sherriff's Department in care of Lt. David Callahan. Lt. Callahan then forwarded the information to The Anderson Police Department due to the jurisdiction of the case being generated from within the Anderson City Limits. I did receive a hard copy of Detective Hoffman's investigative summary and also received an emailed version as well. The above suspect and her husband were interviewed on October 1<sup>st</sup> 2014 with their attorney Dan Whitehead present and a full confession was provided by the above suspect and her husband. The dog was removed from the home and both Nikki and her husband Jason Johnson were told to seek counseling immediately. This activity took place in Anderson, Madison County Indiana. I am seeking a warrant for the above suspect for Bestiality, I.C. 35-46-3-14, a level 6 Felony.
