ORDER OF PRIVATE ADMONITION WITH CONDITIONS

* * * * *

The Inquiry Commission, pursuant to SCR 3.185, has reviewed and considered the Inquiry Commission complaint and the response of Nathaniel Bumppo, Respondent. It makes the following findings of fact and conclusions of law:

- On April 24, 2015, Respondent was charged with Wanton Endangerment,
 1st Degree, a felony, and Resisting Arrest.
- 2. On May 19, 2016, Respondent was indicted on the charges by the Edmonson County Grand Jury.
- 3. On December 19, 2016, Respondent pled guilty to an amended charge of Disorderly Conduct, a misdemeanor, in *Commonwealth v. Bumppo*, 16-CR-00045, Edmonson Circuit Court.
- 4. Respondent was sentenced to twelve (12) months of incarceration, probated for two years, with the condition he undergo a substance abuse assessment and comply with all recommendations.
- 5. SCR 3.130(8.4)(b) states, "It is professional misconduct for a lawyer to commit a criminal act that reflects adversely on the lawyer's honesty, trustworthiness or fitness as a lawyers in other respects..."
- 6. Respondent violated this Rule when he was convicted of the criminal charge of Disorderly Conduct.

The Inquiry Commission has determined that the course of conduct complained of is not shown to warrant a greater degree of discipline than a Private Admonition.

WHEREFORE, Respondent, is privately admonished for his violation of SCR 3.130(8.4)(b).

As a condition of this Private Admonition, Respondent is ordered to successfully complete his two-year criminal probation imposed by the Edmonson Circuit Court on December 19, 2016. Respondent must provide proof to the Office of Bar Counsel upon completion.

As a further condition of this Private Admonition, Respondent is ordered to attend and successfully complete the Ethics and Professionalism Enhancement Program (EPEP) at the Administrative Office of the Courts Building in Frankfort, KY, on April 13, 2018.

As set forth in SCR 3.185, Respondent may, within twenty (20) days from the date of this Admonition, reject this Private Admonition with Conditions, and request a Charge be issued and filed as provided by SCR 3.190, whereupon, the issues shall be processed under the applicable rules.

Further, should Respondent accept this Private Admonition with Conditions, then fail to satisfy the conditions set forth above, the Office of Bar Counsel will so advise the Inquiry Commission, which may result in further disciplinary charges against Respondent including, but not limited to, violation of SCR 3.130(3.4)(c).
