

*Record of Events for Fourteenth Connecticut Infantry,
August 1862-May 1865.*

Field and Staff

Stationed at New Haven, Connecticut, February 27, 1862.

August 23, 1861.— Muster-in roll of the field and staff of the Fourteenth Regiment of Connecticut Volunteers, commanded by Colonel Dwight Morris, called into the service of the United States by the President of the United States from August 23, 1862 (date of this muster) for the term of three years, unless sooner discharged.

I certify, on honor, that this muster roll exhibits the true state of the field and staff of the Fourteenth Regiment, Connecticut Volunteers, and that I have this day accepted them into the service of the United States, for three years or during the War, from August 23, 1862.

Stationed at Fort Ethan Allen, August 23-September 1, 1862.

August 25.— The regiment left Camp Foote, Hartford, Connecticut and proceeded to Washington via New York [City], Harrisburg and Baltimore.

August 28.— Arrived at Washington on this morning and was ordered to Camp Chase.

August 29.— The regiment was ordered to Chain Bridge and thence to Fort Ethan Allen. The arms were distributed to the regiment on leaving for Chain Bridge.

Stationed near Falmouth, Virginia, August 31-December 31, 1862.

August 29-September 7.— The regiment remained at Fort Ethan Allen.

September 7.— Proceeded to join General [William Henry] French's Division in Maryland.

September 13.— Passed through Frederick City, Maryland.

September 14.— Marched to the battleground of South Mountain and encamped near.

September 17.— Was engaged in the battle of Antietam. Remained in the vicinity of the battleground.

September 22-October 30.— Proceeded to Harper's Ferry. Remained in camp on Bolivar Heights.

October 30.— Passed through Virginia.

November 17.— Arrived near Fredericksburg.

November 18.— Started for Belle Plain, remaining there.

December 6.— [The] regiment rejoined the division.

December 11.— Crossed the river.

December 13.— Engaged in the battle of Fredericksburg.

December 15.— Crossed the river again on this evening and encamped near Falmouth, Virginia.

Stationed at camp near Falmouth, Virginia, January-February, 1863.

Stationed at camp near Falmouth, Virginia, March-April 1863.

April 28.— This regiment left camp and proceeded to United States Ford.

April 30.— Crossed the Rappahannock.

Stationed at Union, Maryland, May-June 1863.

May 3.— Engaged at the battle of Chancellorsville, Virginia.

May 7.— Recrossed the river and returned to camp near Falmouth, Virginia.

June 14.— Broke camp and pursued the enemy into Maryland.

Stationed at Elk Run, Virginia, July-August 1863.

July 2-3.— Engaged at the battle of Gettysburg. Pursued the enemy to Williamsport, where they crossed the river.

July 15.— Marched to Harper's Ferry.

July 18.— Left Harper's Ferry.

August 16.— Arrived at Elk Run, Virginia, where the regiment is now encamped. Received three detachments of recruits during the month of August, amounting to 322 men.

Station not stated, September-October 1863.

September 26.— Received 199 drafted men and substitutes for recruits.

October 7.— Received 185 more [men]. The whole number received up to this date is 706.

October 14.— Engaged in the battle of Bristoe Station.

October 20.— Left camp near Centreville and marched to Auburn, where we remained two days.

October 23.— We marched to camp near Warrenton, Virginia, where the regiment is now.

Stationed near Stevensburg, Virginia, November-December 1863.

November 4.— Marched from camp near Warrenton, Virginia to camp near Stevensburg, Virginia, where the regiment is now stationed.

November 26.— Crossed the Rapidan and advanced to Mine Run.

December 2.— Recrossed and are now engaged in building winter quarters (for the fourth time).

Stationed at Stony Mountain, Virginia, January-February 1864.

February 6.— Engaged in action near Morton's Ford on the Rapidan, in which our loss was 115 killed, wounded and missing.

Stationed at Stony Mountain, Virginia, March-April 1864.

Stationed near Petersburg, Virginia, May-June 1864.

May 3.— Broke camp at Stony Mountain, Virginia.

May 4.— Crossed the Rapidan. Took part in the battles of the Wilderness, Spotsylvania, North Anna River, Cold Harbor.

Stationed near Petersburg, Virginia, July-August 1864.

August 25.— Engaged in action at Reams' Station.

Stationed near Petersburg, Virginia, September-October 1864.

October 27.— Engaged in the action of Boydton [Plank] Road.

Stationed near Petersburg, Virginia, November-December 1864.

Stationed near Petersburg, Virginia, January-February 1865.
February 5.— Engaged in action of Hatcher's Run.

Stationed near Burkeville, Virginia, March-April 1865.

Engaged in operations which resulted in occupation of Petersburg and Richmond, Virginia and surrender of Army of Northern Virginia.

Stationed at Bailey's Cross-Roads, Virginia, May 31, 1865.

May 31.— Muster-out roll of field and staff in the Fourteenth Regiment of Connecticut Volunteers, commanded by Colonel Theodore G. Ellis, called into the service of the United States by the President at Hartford, Connecticut (the place of general rendezvous) on May 21, 1862, to serve for the term of three years from the date of enrollment, unless sooner discharged from August 23, 1862 (when mustered in) to August 23, 1865. Discharged May 31, 1865, Special Orders No. 36, Army of the Potomac.

June 26.— Crossed the Potomac at Edwards Ferry this night.

June 27.— Passed through Poolesville and Barnesville, Maryland.

June 28.— Arrived and camped near Frederick, Maryland about 9 p.m.

June 29.— Broke camp about 7 a.m. and arrived at Union, Maryland at 10 p.m., having marched thirty-two miles.

June 30.— Camped at same place.

Stationed at Elk Run, Virginia, August 31, 1863.

Stationed near Warrenton, Virginia, September-October 1863.

September 6.— Broke camp at Elkton, Virginia. Crossed the Rappahannock and marched beyond Culpeper to Cedar Mountain. Remained in front near Robinson's Creek.

October 6.— Marched back to Culpeper and crossed the Rappahannock.

October 11.— Fell back with the main Army toward Centreville, being part of the rear guard of the Army.

October 14.— Were engaged in the battle of Bristoe Station. Crossed Bull Run this same night and remained.

October 19.— Recrossed Bull Run and proceeded to near Warrenton, where we are now encamped.

Station not stated, November-December 1863.

November 8.— Left camp near Warrenton, Virginia. Crossed the Rappahannock River at Kelly's Ford and camped at Milton's Mill.

November 25.— Broke camp and crossed the Rapidan River at Germanna Ford. Marched to Mine Run and remained there.

December 2.— Recrossed the Rapidan and returned to Milton's Mill.

December 6.— Marched to Stevensburg.

December 28.— Broke camp at Stevensburg and marched to Morton's Ford, where we are now encamped.

Stationed at Stony Mountain, Virginia, January-February 1864.

February 6.— Crossed the Rapidan River at Morton's Ford, Virginia and engaged the enemy during the evening. During the night, fell back to the north bank of the river and remained there.

February 7-8.— Returned to camp.

Stationed at Stony Mountain, Virginia, March-April 1864.

Have remained in camp near the Rapidan since last muster.

Stationed near Petersburg, Virginia, May-June 1864.

June 18.— Marched to Centreville; from there to Gainesville, where we remained three days.

June 20.— Broke camp and marched to Gum Springs.

June 26.— To Edwards Ferry, crossing the Potomac.

June 27.— Took up line of march. Passed through Poolesville and Barnesville and encamped near Sugar Loaf Mountain.

June 28.— Passed through Urbana and camped near Frederick City.

June 29.— Marched thirty-two miles. Passed through Liberty and encamped at Union.

Stationed at Elkton, Virginia, July-August 1863.

July 1.— Marched from Union, Maryland and reached Gettysburg.

July 2.— Supported [William A.] Arnold's Battery in the fight.

July 3.— Aided in repelling the enemy's attack on our center.

July 5.— Left Gettysburg. Marched through Taneytown, Frederick, Jefferson, Burkeville, and Rohersville.

July 10.— Were in line of battle in front of the enemy near Falling Waters, till they recrossed the Potomac.

July 18.— Marched to Harper's Ferry; crossed the Potomac and continued march through Loudoun Valley.

July 28.— Reached Manassas Gap. From there marched to White Plains, Warrenton, Warrenton Junction.

August 1.— Were detached on picket duty near Bristoe Station, Virginia.

August 18.— Returned and went into camp near Elkton, Virginia.

Stationed near Warrenton, Virginia, September-October 1863.

September 1.— Left Hartwood Church, Virginia, where our Corps had supported General [Hugh Judson] Kilpatrick's Cavalry in an expedition to the Rappahannock.

September 12.— Returned to Elkton, Virginia. Marched to Rappahannock Station; crossed the Rappahannock and marched to Culpeper, Virginia.

September 16.— Marched to Cedar Mountain, Virginia and performed picket duty on the Rapidan River.

October 6.— Recrossed the Rappahannock River.

October 12.— Crossed again.

October 13.— Returned to the north bank.

October 14.— Fell back on the Orange and Alexandria Railroad and took part in an engagement at Bristoe Station. Lost one killed and six missing. Crossed to Centreville (crossing Bull Run).

October 17.— Moved again with the Army after General [Robert Edward] Lee.

October 23.— Encamped near Warrenton, where we still remain.

Stationed near Rapidan, November-December 1863.

November 7.— Broke camp near Warrenton Junction. Crossed the Rappahannock River.

November 8.— Went into camp near Stevensburg.

November 28.— Broke camp and crossed the Rapidan. Marched to Robertson's Tavern. Had a slight skirmish with the enemy.

December 8.— Recrossed the Rapidan and went into camp near Stevensburg.

December 28.— Broke camp again and moved near the Rapidan River, where we are now encamped.

Stationed near Stevensburg, Virginia, January-February 1864.

February 6.— Broke camp near Stevensburg, Virginia. Crossed the Rapidan at Morton's Ford. Had a skirmish with the enemy.

February 8.— Recrossed the Rapidan and returned to our former camp near Stevensburg, where we are now.

Stationed at Stony Mountain, Virginia, March-April 1864.

Have been in camp at Stony Mountain for the last two months.

Stationed near Petersburg, Virginia, May-June 1864.

May 3.— Left camp at Stony Mountain in the evening.

May 4.— Crossed the Rapidan at Ellis' Ford. Camped at night in the woods at Chancellorsville.

May 5-6.— Started early this morning towards the Wilderness. Had an engagement with the enemy.

May 7.— Also at Spotsylvania. Marched to Petersburg, crossing the Mattapony, Pamunkey, Chickahominy, and the James Rivers. Have been engaged in all the battles and skirmishes of our Corps until the present time. Are now in camp near Petersburg, Virginia.

February 28-April 28.— Remained in camp near Falmouth, Virginia.

April 28.— Marched to United States Ford.

Stationed at Union, Maryland, May-June 1863.

May 3.— Fought the battle of Chancellorsville, Virginia.

May 5.— Returned to camp near Falmouth, Virginia.

June 17.— Left camp near Falmouth, Virginia and marched into Maryland.

June 30.— Encamped at Union, Maryland.

Stationed at camp near Elk Run, Virginia, August 30, 1863.

July 1.— Marched from Union, Maryland.

July 2-3.— Engaged in the battle of Gettysburg.

July 5.— Marched to near Warrenton Junction by way of Williamsport, Harper's Ferry, Loudoun Valley, and Warrenton near Elk Run, where we are now encamped.

November 7.— Moved from camp near Warrenton Junction.

November 28.— Broke camp and crossed the Rapidan River. Marched to Robertson's Farm.

December 2.— Had a slight skirmish with the enemy.

December 8.— Recrossed the Rapidan and went into camp near Stevensburg.

December 27.— Broke camp again and moved near the Rapidan River, where we are now encamped.

Stationed at Stony Mountain, Virginia, January-February 1864.

February 6.— Broke camp and crossed the Rapidan River. Skirmished heavily with the enemy until dark, when we recrossed the river and returned to the old camp, where we have since remained.
