**Special Needs Class:** All Ages. Class is based on straight time, no D's. FREE ENTRY FEE – PRIZES AWARDED.

**Beginners:** 14 & Under Beginners (ponies, trotters & Lopers...cannot enter in other classes other than AQHA Youth for points only). Entries will be allowed to stay in Beginners until they run a time equivalent to placing in the Open 5D twice. Ability based on rider not the horse. 5D is full second splits.

**PBRIP Entries:** \$10 of entry goes to APHA per program requirements.

**Canadian County Sidepot Entries:** Must be a resident within Canadian County boundaries.

**AQHA Entries:** If you choose to enter Open jackpots, AQHA time will carry over, you will not make a second run. **AQHA Exhibitors must provide copy of CURRENT INDIVIDUAL MEMBERSHIP CARD and FRONT SIDE OF REGISTRATION PAPERS.** AQHA entries must check in at office no later than 6pm to provide horse registration paper and membership copies (you may email them prior to show to [Lona.Spears@trikbarrels.com](mailto:Lona.Spears@trikbarrels.com)), as well as to **pick up AQHA blanket number!** AQHA Sidepots will be paid on entire AQHA draw order, not by division; it will be paid out as 5D with ½ second splits. **Be sure to turn in an AQHA Medical Report Form if you are administering any medications to your horse.** Events are subject to random drug testing by AQHA. We **NEVER** know when they will send a testing agent, and we have had testing agents at many of our shows in the past.

**Substitutions: ALLOWED UNTIL 6pm day of race.** You MAY NOT sell your entry to someone else, however, you may draw yourself out and apply your fees to their run. (A new number will be drawn for them at that time). Another barn fee may be required depending on if the person has already entered for that day or not.

**Refunds: ALL REFUND REQUESTS MUST BE SUBMITTED by 6pm day of race.** Must have a Vet Out or Dr Release for refund, and/or subject to approval by management. Office Charges will be retained for benefit. You may also donate your entry refund to the cause, just let us know. Entries via credit card will not be refunded convenience/service fees charged by online and/or credit services as well.

**Co-Sanction Approvals:** BBR, AQHA/OQHA, Appaloosa Incentive & PBRIP. Please check association schedules for confirmation of approval.

**Health Requirements per State Law:** Negative Coggins Required for all horses; Out of State Horses require 30 day Health Certif.

**Pre Draws and Results:** Posted on [www.fastenter.com](http://www.fastenter.com). Pre-Draws should be posted on or before Tuesday before race. Please note all late entries may not appear on Pre-Draw posting if entered after pre-draw deadline. We post updated draw 30 minutes before each class the day of the race. If you need to know earlier, please check in at office. Late walk ups will run at the end of the draw.
